**Subject: WELLTH Fund practice videos**

The fund provides the opportunity for proactive care and grants up to R10,000 in wellness benefits per family, without affecting the Medical Savings Account. It encompasses a wide range of healthcare services and is a one-time benefit, accessible for a maximum duration of two years until December 2024. The benefit becomes accessible upon completion of the Health Check.

**Unlocking the WELLTH Fund**

To unlock the WELLTH Fund, all members on the DHMS policy, aged two years and older, must have completed their relevant, in-person Health Check or an [Kids Health Review](#) for children two years and older any time from 01 January 2022.
