

JEFF x Vitality - SA's Biggest Workout Anniversary

- 1. The promoters of the competition are Discovery Vitality (Pty) Ltd ("Discovery Vitality") and Johno's Fitness (Pty) Ltd ("JEFF").
- 2. This competition will take place on 18 April 2022 from 08:00 to 08:45. Participants may submit proof of the workout on the Vitality Race Events page between 18 April 2022 08:00 and 22 April 2022, 23:59.
- 3. Any activities/entries made before or after this date will not be considered.
- 4. The competition is open to all Discovery Vitality members 18 and over.
- 5. To be eligible, participants must submit their "JEFF x Vitality SA's Biggest Workout Anniversary" workout on the Vitality Race Events page.
 - 5.1. Points awarded from participating in the workout sessions will reflect within 7 working days from date of submission.
- 6. Points are awarded on an individual level, not on a policy level, therefore each Member will need to log in to the Discovery Website and manually submit their completed workout by following the below steps in order to be awarded the points:
 - 6.1. Log into the Discovery website
 - 6.2. Select Vitality
 - 6.3. Select "Gym, devices and fitness"
 - 6.4. Under "Vitality Race events", select "Claim points for Vitality race events"
 - 6.5. Under "Manually submit your race results", capture The following fields:
 - 6.6. Event name The name of the event (Event Name: JEFF x Vitality SA's Biggest Workout Anniversary)
 - 6.7. Event date 18 April 2022
 - 6.8. Race type The event name will appear on the drop down menu and should be selected
 - 6.9. Race number ID number or passport number
 - 6.10 Distance The event name will appear on the drop down menu and should be selected
 - 6.11. Time Members need to fill in both time fields. For example: if you trained for 1 hour 30 minutes 01hours 30mins or if you trained for 45 minutes 00hours 45mins
 - 6.12. Upload a screengrab of you being logged in to the workout
 - 6.13. Enter the URL where the event will be hosted i.e. the URL for Zoom or the Discovery Vitality Facebook page
 - 6.14. Agree and submit
 - 6.15. The results will be verified and you will receive your 300 points
- 7. By selecting "JEFF x Vitality SA's Biggest Workout Anniversary", as the event name on the Vitality Race Events portal, members will be entered into the event in order to be eligible for 300 Vitality points.
- 8. By selecting "JEFF x Vitality SA's Biggest Workout Anniversary + Competition" as the event name on the Vitality Race Events portal, members will be entered into the event in order to be eligible for 300 Vitality fitness points and-opt-in-for-the-competition to win a Fitbit Charge 4, Fitbit Versa 3 and a Fitbit Luxe and 10 x Monthly JEFF Club memberships valued at R595 per month.
- 9. Members are only allowed to enter the competition once.
- 10. After the closing date, the winner will be selected through a random draw. The draw will take place by 26 April 2022 and the winner will be contacted by 29 April 2022.
- 11. Discovery Vitality will attempt to contact the winner by either telephone, email or both. Should the prize not be claimed within two months the winner will forfeit his/her prize and a new winner will be selected.
