

Join Team Vitality 2021 competition terms and conditions

1. The Promoters of the Team Vitality Quarter 1 Campaign are Discovery Vitality (Pty) Limited ("Discovery Vitality") and Discovery Athletic Club N.P.O. operating as Team Vitality ("Team Vitality").
2. The competition is open to Team Vitality members who have joined in January and February of 2021 and Vitality members over the age of 18 years old for Team Vitality memberships and between 16 and 18 years old for Junior Team Vitality memberships. Members under the age of 18 will need to have their parent/legal guardian join Team Vitality and enter the competition on their behalf.
3. To enter the competition, participants must join Team Vitality and email the required information to RSVPTeamVitality@discovery.co.za.
- 3.1. Participants must mention the following in the email: Their name, surname, Vitality membership number or ID/Passport number.
4. By completing the actions above, participants stand a chance of winning a 30-minute Zoom consultation with Bruce Fordyce for runners or Nic White for cyclists, followed by a personalized running or cycling 12 week programme put together by the athlete.
5. The competition period will run from 00:01 on 21 January 2021 to 23:59 on 31 March 2021.
6. Winners will be randomly selected on 12 April 2021 and will be notified that they have won by 19 April 2021.
7. Entrants into the competition are required to reside in South Africa.
8. There are a total of 6 (six) prizes which will be awarded to winners of the competition. This comprises of 3 (three) thirty-minute Zoom consultations with Bruce Fordyce followed by a customized 12-week training programme for runners, and 3 (three) thirty-minute Zoom consultations with Nic White followed by a customized 12 week training programme for cyclists.
9. Only one prize will be awarded per member.
10. Only one entry is permitted per member.
11. Any activations done before or after the above mentioned dates will not be considered.
12. The winner will be contacted on either telephone, email or both. With their written consent, the winners may be required to appear and be identified on the Vitality social media pages and/or Team Vitality platforms, such as the Team Vitality newsletter at no fee to them. The prize winners can decline the option of appearing or being mentioned on the Vitality social media pages and/or Team Vitality platforms and will

not forfeit the prize should they elect to do so.

13. Discovery Vitality will attempt to contact each of the winners by email and phone. Should the prize not be claimed within 2 (two) months the prizes will be forfeited and a new winner chosen.
