

DISCOVERY BANK RWC #SPENDTREND COMPETITION TERMS AND CONDITIONS

These terms and conditions apply to the RWC #SpendTrend competition taking place from 9 to 15 November 2023. Discovery Bank will give away a travel voucher worth R10,000 to one winner.

The competition is open to anyone who meets the eligibility criteria below. Qualifying participants earn one entry for each reply on X that includes an answer to the question and the hashtag #DiscoveryBestBank in reply to one of @Discovery_SA's three #SpendTrend competition posts on X from 9 to 15 November 2023. The competition will end at 23:59 (South African Standard Time) on Wednesday, 15 November 2023.

By taking part in this competition, you agree to and accept these terms and conditions. This competition can end at the promoter's discretion.

The competition and who qualifies
