

# Discovery Bank and EasyEquities sign-up offer

These terms and conditions apply to the campaign run by Discovery Bank and EasyEquities to award a R50 sign-up bonus to participants who open new EasyEquities accounts using the Discovery Bank app.

# The offer and who qualifies

- 1. The promoters are Discovery Bank Ltd ('Discovery Bank'), Discovery Vitality (Pty) Ltd ('Discovery Vitality'), also referred to as 'promoters', 'us', 'we', and 'our'.
- 2. The 'participant' is the qualifying client who has chosen to take part in the competition.

- b. 6.2 Your account must be kept in good standing as defined <u>here</u>.
- 7. Participating clients must have opened their EasyEquities account using the Discovery Bank mobile app.
  - 7.1 An EasyEquities account constitutes as opened once the relevant activation process has taken place in accordance with EasyEquities processes, this includes FICA verification. Participants can reference the EasyEquities <u>list of required FICA documentation</u>.
- 8. The promoters' directors, partners, employees, agents, or consultants, as well as any other similarly associated individual with Discovery Ltd, Discovery Bank Ltd, Discovery Vitality Ltd, its partners, or any related third parties, are not eligible for this promotion.

  - a. Any losses that you may suffer because of any failed or unsuccessful transmission of instructions to EasyEquities
