## GROUP RISK POLICYHOLDERS

As an employer or retirement fund, you are the policyholder under a Discovery Group Risk policy underwritten by Discovery Life Limited, being a licensed life insurer.

When you engage with us, you provide us with personal information about your organisation and other data subjects (as defined in the Protection of Personal Information Act), including your employees or retirement fund members, their spouses, dependants, beneficiaries, or any other data subjects who are related to you or under your authority (as may be relevant depending on the context).

We will process your personal Information and that of other data subjects only in accordance with the purposes set out in the Group Privacy Statement and any other related purposes as set out in the terms and conditions of the Group Risk policy.

## MEMBERS OF GROUP RISK SCHEMES

As a member of your employer's or retirement fund's ("policyholder") group risk policy, you are member of a Discovery Group Risk policy underwritten by Discovery Life Limited, being a licensed life insurer issued to the policyholder.

When you engage with us personally, you provide us with personal information about yourself and other data subjects (as defined in the Protection of Personal Information Act), including your spouses, dependants, beneficiaries, or any other data subjects who are related to you or under your authority (as may be relevant depending on the context).

We will process your personal Information and that of other data subjects only in accordance with the purposes set out in the Group Privacy Statement and any other related purposes as set out in the terms and conditions of the Group Risk policy.

## DISCOVERY LIFE PENSION AND PROVIDENT FUND EMPLOYERS

As a participating employer in the Discovery Life Pension Umbrella Fund or Discovery Life Provident Umbrella Fund or both ("collectively known as the Discovery Retirement Funds") you and your employees are participants in the Discovery Retirement Funds, which is underwritten by Discovery Life Limited, being a licensed life insurer.

When you engage with us, you provide us with personal information about your organisation and other data subjects (as defined in the Protection of Personal Information Act), including your employees who are retirement fund members, their spouses, dependants, beneficiaries, or any other data subjects who are related to you or under your authority (as may be relevant depending on the context).

We will process your Personal Information and that of other data subjects in accordance with the Rules of the Discovery Retirement Funds, the service level agreement entered into with the Discovery Retirement Funds and Discovery Life Limited, the Funds appointed section 13B, and in accordance with purposes set out in the Discovery Group Privacy Statement.

## DISCOVERY LIFE PENSION AND PROVIDENT FUND MEMBERS

By virtue of your employment with your employer who participates in the Discovery Life Pension Umbrella Fund or Discovery Life Provident Umbrella Fund or both ("collectively known as the Discovery Retirement Funds") you are member in the Discovery Retirement Funds, which is underwritten by Discovery Life Limited, being a licensed life insurer.
