

Diabetes Clinic Networks for Pharmacies 2023 Project Description and specifications

BACKGROUND

Diabetes education and self-management tools and training enable members living with diabetes to better control their health and can improve quality of life. Diabetes educators can provide this education and training.

A diabetes educator can be a registered nurse or dietician who has completed (a) the required training course(s) and (b) minimum practical experience.

The schemes administered by Discovery Health have included 2 diabetes education consultations with a Diabetes Educator as part of the Scheme benefits from January 2023.

In order to claim for the services Discovery Health has created a Diabetes Clinic Network.

- Interested pharmacies and pharmacy groups will need to contract with Discovery Health
- Diabetes educators will need to fulfil all the entry requirements (diabetes course and additional practical experience) to be part of the Diabetes Care Clinic Network.

Communication to pharmacy clinics went out at the end of November 2022.

Provision for the claims' submission and payment for the following services have been made:

- Two (2) diabetes education sessions per annum, payable from risk
- An annual foot screening, payable from risk



 Point of care pathology tests as referred by the treating doctor, limited to those tests in the diabetes basket of care.

Three verification networks will be created for claims submission and payment:

- 1. **Contracted clinic pharmacies** (as the billing provider with a valid BHF number) participating in the Diabetes Clinic Network.
- 2. Diabetes Educator as a treating provider registered on one of the following two networks:
 - 2.1. *A Diabetes Educator Network for diabetes nurse educators who have completed the diabetes course and are busy with the practical training in the pharmacy clinic
 - 2.2. *A Diabetes Educator Network for diabetes nurses who have completed the diabetes course and have acquired the required experience.

Decision: *For networks 2.1 and 2.2 our final decision is that the diabetes educator needs a valid BHF number as identifier for claim verification purposes.

A diabetes educator who is not a registered nurse will not be able to claim for pathology and foot screening as this is outside their scope of practice.

PARTICIPATING SCHEMES

It is expected that most schemes administered by Discovery Health will participate from 1 January 2023. Final discussions with the Schemes are underway.

REQUIREMENTS FOR THE CLINIC PHARMACY PARTICIPATION IN THE DIABETES CLINIC NETWORK

Participation of the pharmacy clinic in the Diabetes Clinic Network is voluntary and open to any pharmacy clinic that meets the following clinic requirements:

- *At least one diabetes educator that qualifies for participation in the Diabetes Clinic Network with an own nurse's valid BHF number
- A private consultation room within the pharmacy
- Appropriate clinic equipment and furniture
- A bathroom that is easily accessible
- *An electronic clinical practice management claims submission system with the ability to submit the diabetes educator practice number as the *treating provider* in the claim.
- Ability to send results and reports to the treating doctor and Discovery Health
- Appropriate referral networks in place (including pathology and general practitioners).
- Diabetes educators must be clearly and visibly indicated in the pharmacy and the clinic.

SERVICES AND RATES FOR 2023

New diabetes educator procedures

The results obtained in the pharmacy need to be made available to the treating doctor and to Discovery Health (HID2.0) when it becomes available.

- Pathology codes are only payable when the tests are requested and referred by the treating doctor and indicated on the claim.
- Please note: For diagnostic purposes, Discovery Health require a pathology laboratory test.

^{*} Without these changes, the pharmacy will not be able to successfully claim for these services.



- The below codes are for monitoring purposes.
- Discovery Health will make available a laboratory pathology referral form for use by clinic pharmacies.
- The results obtained in the pharmacy need to be made available to the treating doctor and to Discovery Health (HID2.0).

NEW CLAIM FORMAT REQUIREMENTS

The pharmacy, through their software provider and switch (MediSwitch & MediKredit Switch), should make the new claim format available with 3 provider fields per claim line in the XML from 1 January 2023:

- 1. Existing 'billing' provider field for the pharmacy practice number
- 2. Existing 'referring' provider field for the prescribing doctor practice number.
- 3. A **NEW 'treating'** provider field for the diabetes educator who is rendering the service. A BHF number will be used to identify the nurse who has delivered the service.

REQUIREMENT

MediSwitch is mapping the pharmacy's XML to the Discovery XML.

ACTION REQUIRED FROM PMA

- 1. Field 3 versus Field 6
 - Field 3 is reserved for the PCNS Number
 - Field 6 is reserved for the Professional Council number, indicated by X.
 - For Diabetes Educator claims, Discovery Health reads the last seven digits of the long (13 digit) or short (7 digit) PCNS Number in field 3.
