# Your investment in the Discovery Capital 200+ (June 2018 tranche) has matured

You invested in the Discovery Capital 200+ (June 2018 tranche), which is a five-year product that provided exposure to the performance of the European and US equity markets.

The global portfolio comprised 70% Euro Stoxx 50 and 30% S&P 500 price indices. If the global portfolio is flat or positive at the end of the five-year period, the Discovery Capital 200+ provides a 100% gross return before the effect of any administration fees, financial adviser fees, and taxes, where applicable.

## How your investment performed

The five-year period ended on 1 June 2023. The cumulative return of the global portfolio was positive 32.6% at this date. As such, you will get a 100% gross return on your initial investment before the effect of fees and taxes.

We would like to answer some important questions you might have:

## Tax payable on the proceeds of the Discovery Capital 200+

All proceeds are treated as capital gains for tax purposes. Tax is deducted within the Endowment and will be paid on your behalf by Discovery Life.

## Benefits of staying invested in your current Endowment

If you withdraw your investment and reinvest in a new Discovery Endowment, you may incur additional costs and possible investment restrictions. Capital gains tax will also be recovered from your policy on withdrawal. Staying in your investment will avoid these costs and give you access to the wide range of funds available on our platform. ### What happens to your investment now?

In the Discovery Capital 200+ June 2018 tranche fact sheet, we stated that the proceeds of this tranche will be switched into a new tranche of the Discovery Capital 200+ if one is available. If a new tranche was not available, the proceeds would be switched into the Discovery Money Market Fund.

Because there is no new Discovery Capital 200+ tranche, we began the process to switch the proceeds of your investment into the Discovery Money Market Fund. This process will take up to 12 business days to complete from 1 June 2023. The investment will not earn interest while its proceeds are in transit. Once this is done, you can switch your proceeds into any fund of your choice available on the Discovery platform.
