SARS enhances tax directives from <April 2023>

The South African Revenue Service (SARS) issued a communication in <February 2023> to all taxpayers. This communication affects your annuity income for the tax period <April 2023 to February 2024>. In line with this, we have received updated details from SARS and applied the changes to your investment.

The updated tax rate on your investments with us as at <April 2023> is an instruction from SARS. They've asked us to apply a tax percentage of <xx.xx%> to your annuity income for <April 2023 to February 2024>.
