The Discovery Miles Integrator rewards you for taking responsibility for your financial future. It provides you with a boost to your Discovery Miles when you invest them for your retirement with Discovery Invest.

If you have Discovery Miles activated on your Discovery Card, then on 25 April 2022 Discovery Invest will automatically transfer 100% of your Discovery Miles balance (up to a maximum of 1 Discovery Mile for every R10 of your lump-sum Retirement or Preserver Plan fund balance) into the Discovery Miles Integrator. We will boost every Discovery Mile transferred into the Discovery Miles Integrator by up to 300%, depending on your Vitality status and your plan type, as shown in the table below.

The Discovery Miles Integrator will grow in line with the growth of your portfolio of selected funds, after the deduction of the fund management fees, Discovery's annual administration fees and any ongoing financial adviser fees, until your Boost Vesting Date\*. This was detailed in your policy schedule when you initially took out your lump-sum Retirement or Preserver Plan.

You need to remain invested until your boost vests to get the full value of the Discovery Miles Integrator. Once the miles have been transferred into the Discovery Miles Integrator, the rules of the Discovery Miles Integrator will apply and you will not be able to transfer the Miles back into your Discovery Card.
