## Update on your investment in the Discovery Enhanced Yield Fund

You have just completed the fourth year of your investment in the Discovery Enhanced Yield Fund (July 2018 tranche) on your lump-sum Discovery <Product>. Since its inception on 31 July 2018, we have been monitoring its performance closely and have kept you informed by providing monthly performance reports on the Discovery website.

As at 1 August 2022, the cumulative four-year return of the FTSE 100 Index was negative 4.33%. Due to this negative performance, the Discovery Enhanced Yield Fund has rolled over for another year and has not matured. If the performance of the fund is favourable in a year's time on 31 July 2023 (i.e. the FTSE 100 Index is flat or positive from its starting price on 31 July 2018), you will receive a cumulative gross return of 75%\* to your investment at the end of the fifth year of the Fund. We will let you know at that point.
