SARS changes tax directives from March 2022

In line with the communication issued by The South African Revenue Service (SARS) in January 2022 to all taxpayers, and our communication sent to you in early February 2022 regarding the implementation of the above, we want to inform you that your Annuity Incomes for the tax period <March 2022 to February 2023> have been affected.

The impact to your <investment/investments> with us as at 1 March 2022, is an instruction from SARS to apply a tax percentage of <xx.xx%> to your Annuity Income for the period <March 2022 to February 2023>.
