# Closure of the Discovery Escalator - Discovery Equity Fund (Capped)

Thank you for investing with Discovery. We are continually enhancing our offerings and making your money work harder for you.

The merger of the Discovery Dynamic Equity Fund with the Discovery Equity Fund on 15 February 2019 resulted in the Escalator Fund that you are currently invested in being capped to new investments (excluding existing recurring contributions that you are already investing monthly). In order to streamline and simplify our investment offering, we are closing this fund on <21 July 2020>.

## How this affects you

From the date of the fund closure, all the assets remaining in the Discovery Escalator – Discovery Equity Fund (Capped) will be transferred to the Discovery Escalator – Discovery Equity Fund. You may notice a switch on your statement reflecting this.

The two funds are identical in nature as they are invested in the same risky asset, with only a small difference in allocation between the risky asset and the cash allocation. However, there may be a slight difference in the downside protection levels of these two funds. At present, the effective underlying guarantee level will remain the same. Note that the switch will trigger a capital gains tax event. The boosts, integration benefits and protectors on your investment (if applicable) will remain unaffected.
