Terms and conditions

These terms and conditions apply to the 72-hour early access that Discovery Bank is offering its clients for the 2027 Totalsports TWO OCEANS MARATHON powered by BYD. By taking part in this benefit, you agree to and accept these terms and conditions.

Definitions

- 1| The promoters are Discovery Bank Ltd ('Discovery Bank') and Totalsports TWO OCEANS MARATHON powered by BYD (TTOM), also referred to as 'promoters', 'us', 'we', and 'our'.
- 2| The 'client' is an existing Discovery Bank client who is eligible to receive the benefit.

People **who qualify**

- 4| You are aged 18 years or older and your account is in good standing (as defined [here](#)).
- 5| Discovery Bank clients who have savings only products should upgrade to a qualifying Discovery Bank transaction or credit card account before midnight on Friday, 24 July 2026 to access the Discovery Bank TTOM early access benefit.
- 6| If you have the previous Discovery Card product, which is now administered by Discovery Bank, you must switch your previous Discovery Card to a new Discovery Bank credit card product to qualify for the early access before midnight on Friday, 24 July 2026.
- 7| New clients must successfully apply for, be approved for, and hold an active qualifying Discovery Bank product by 23:59 on Sunday, 26 July 2026 to qualify for the early access benefit. Submitting an application does not guarantee approval or eligibility for this benefit.
- 8| All Discovery Bank credit and account terms and conditions will apply, and credit approvals depends on income verification and creditworthiness
- 9| Discovery Bank clients need to hold an active, qualifying Discovery Bank account as of 23:59 on Sunday, 26 July 2026 to access this benefit.

- 12| Discovery Bank clients with qualifying bank accounts will need to verify themselves with their South African ID number to gain access to the early access. Discovery Bank clients who are foreign nationals will need to verify themselves with their passport number in order to gain access to the early access.
- 13| The ID or passport number provided for eligibility verification must match the details captured on the participant's TTOM profile.
- 14| A race entry is not guaranteed for each client on the early access: availability depends on the popularity of the early access. Once entry allocations are sold off the early access will end.
- 15| A TTOM race entry is subject to the [TTOM terms and conditions](#) on the TTOM website. Clients should use their race entry in line with these terms and conditions.
- 16| Only a Discovery Bank early access race entry bought from TTOM Link is legitimate.
- 17| TTOM is responsible for selecting the races, race dates, as well as setting race entry prices and managing all other event details.
