

Terms and conditions

Discovery Bank virtual card campaign

19 September – 30 November 2023

These terms and conditions apply to the Discovery Bank virtual card campaign.

Discovery Bank will donate one rugby ball or netball to sports development in South Africa for every 50 taps a client makes from a digital wallet with a virtual debit or credit card from 19 September to 30 November 2023.

By taking part in this campaign, you agree to and accept these terms and conditions.

More about the **campaign**

- 1 The 'promoter' is Discovery Bank Ltd, also referred to as 'promoter', 'us', 'we', and 'our'.
- 2 The 'participant' is the Discovery Bank client who has chosen to take part in the campaign.
- 3 All information relating to this campaign and any information we publish on any promotional material forms part of the terms and conditions.
- 4 The campaign starts on **19 September 2023** and ends at 23:59 (South African Standard Time) on **30** November 2023.

Qualifying for the campaign

- **5**| This campaign is open to all Discovery Bank clients with a Discovery Account, Transaction Account, Credit Card Account or Suite, whose accounts are in good standing.
- 6 | Clients must be 18 years or older.
- 7 A client must use or add a virtual debit or credit card, and for every 50 taps made from a digital wallet using Apple Pay, Fitbit Pay, Garmin Pay, Google Pay, Samsung Pay and SwatchPAY!, we'll donate one rugby ball or netball to sports development in South Africa.
- 8| Taps must be for a minimum of R10 per payment.
- 9 Only taps with a virtual card and not a physical card will count.
- 10 Online purchases made with a virtual card will count too.
- 11 | If clients have several virtual cards, they may use any virtual card to make a qualifying payment.

Additional terms and conditions

12| Discovery Bank clients who meet the eligibility criteria will donate one rugby ball or netball each to sports development in South Africa.



- **13**| Discovery Bank will donate a total of 5,000 rugby balls and 5,000 netballs to the following sports development charities and organisations:
 - 13.1. The Tag Rugby® Association
 - 13.2. VUKA Rugby
 - 13.3. The South African Deaf Rugby Association.
 - 13.4. Dreamfields
 - 13.5. Netball South Africa
- **14**| If Discovery Bank clients do not collectively raise the full allocation of 5,000 rugby balls and 5,000 netballs, Discovery Bank will top up the contribution to achieve the target of 10,000 rugby balls and netballs.
- 15 | Discovery Bank account terms and conditions apply.
- **16** The promoters reserve the right to cancel or change the campaign rules without giving notice ahead of time. If this happens, participants will lose and abandon any rights they may have against the promoters, our affiliates, and associated companies to the extent permitted by law.
