

## Discovery employee Vitality Fitness benefit Terms and Conditions

These terms and conditions are for the **Discovery employee Vitality Fitness benefit**. Qualifying Discovery employees with an active Vitality membership, can get up to 10 free workouts a month to exercise anywhere with Vitality Fitness.

### What is **Vitality Fitness**?

Vitality Fitness is a first-of-its-kind integrated exercise platform. Qualifying members can exercise anywhere and explore a world of workouts in just a few taps in the Discovery app. They can book workouts at a fitness facility of their choice within our Vitality Fitness network.

### The campaign **and who qualifies**

1. The promoters of this campaign are Discovery Vitality (Pty) Ltd, also referred to as **'promoter'**, **'us'**, **'we'**, and **'our'**.
2. The campaign also referred to as **'offer'**, **'offering'**, **'promotion'**, **'benefit'**.
3. The 'participant' is the qualifying Discovery employee (including permanent employees and Agents with benefits (DFCs) only) who has chosen to take part in the campaign, also referred to as **'you'**, **'your'**.
4. All information relating to this campaign and any information we publish on any promotional material forms part of the terms and conditions.

### Qualifying for this **campaign**

5. This benefit is open to all qualifying Discovery employees (including permanent employees and Agents with benefits (DFCs) only) of the Discovery group of companies ("the Discovery Group") over the age of 18 years old and:
  - 5.1. Are primary account holders of a Discovery Account, Discovery Bank Transaction or Credit Card account or Discovery Bank Suite.
  - 5.2. Have an active Vitality Money status.
  - 5.3. Have Vitality Pay activated.
  - 5.4. Have a compatible iOS (Apple), Android or Huawei device to access the platform in the Discovery app.
  - 5.5. Have downloaded or updated to the latest version of the Discovery app.
6. Participants with Discovery Bank savings products only must upgrade to a Discovery Bank credit card account (Card Account or Suite) or Discovery Bank Transaction account to qualify for the benefit.
7. Participants with the previous Discovery Card product, which is now administered by Discovery Bank are required to switch their previous Discovery Card to a new Discovery Bank credit card product and activate Vitality Money to qualify for the benefit.

## Free workouts

8. All Vitality members get **2 free workouts** a month on Vitality Fitness. Permanent Discovery employees get **2 additional free workouts** a month. And the higher your **Vitality Health status**, the more free workouts you get:

| Vitality Health status | Number of additional free visits |
|------------------------|----------------------------------|
| Blue                   | 0                                |
| Bronze                 | 2                                |
| Silver                 | 2                                |
| Gold                   | 6                                |
| Diamond                | 6                                |

9. Your Vitality Health status as at the 25th of the previous month will determine your allocation for the following month.
10. The free workouts will be allocated at the start of each calendar month and will expire at the end of that calendar month (in line with the standard rules relating to free monthly visits).
11. If you have a current recurring membership with a Vitality Fitness facility, you will not be able to use your two free Vitality workouts at that facility.
12. For updates on free workout campaigns, please refer to the Vitality Fitness platform on the Discovery app.
13. Monthly free workouts exclude Planet Fitness and Virgin Active through Vitality Fitness.
- 13.1. Qualifying members will receive their first three visits per gym partner for free. These are not subject to the monthly expiry and cannot be reallocated.
- 13.2. These are once per lifetime, after which you can continue to book classes at Virgin Active or get access passes at Virgin Active and Planet Fitness at a pay per visit rate. This excludes Virgin Active Collection Clubs
