

Discovery employee Vitality Gym campaign 2026

Terms and Conditions

These terms and conditions are for the Discovery employee Vitality Gym campaign running from **9 March – 30 April 2026**. Qualifying Discovery employees can join Virgin Active or Planet Fitness and pay zero activation fees on a local club membership. As a Vitality member the Discovery employee will also get up to 75% off their monthly gym fees.

1. The promoters for this campaign are Discovery Vitality (Pty) Ltd, also referred to as 'promoter', 'us', 'we', and 'our'.
2. The campaign, also referred to as '**offer**', '**offering**', '**promotion**'.
3. The 'participant' is the qualifying Discovery employee who has chosen to take part in the campaign, also referred to as '**you**', '**your**'.
4. All information relating to this campaign and any information we publish on any promotional material forms part of the terms and conditions.

The campaign **details**

5. The campaign will be from 9 March 2026 until midnight 30 April 2026. Any activity or activation made before or after these dates will not be considered.
6. This campaign is open to all qualifying Discovery employees (including permanent employees and Agents with benefits (DFCs) only) of the Discovery group of companies ("the Discovery Group") over the age of 18 years old who meets all these criteria:
 - 6.1. The participant has not activated the Vitality Gym benefit with Virgin Active or Planet Fitness.
 - 6.2. The participant has a Vitality Health policy (Vitality Premium for Planet Fitness, Vitality Premium or Vitality Active with Vitality Money for Virgin Active) that qualifies for the Vitality Gym benefit.
7. Vitality Active members require a qualifying Discovery Bank product:
 - 7.1. Are primary accountholders of a Discovery Account, Discovery Bank Transaction or Credit Card account or Discovery Bank Suite (excluding savings accounts and the old Discovery Card).
 - 7.2. Have an active Vitality Money status.
8. This campaign is only valid for Virgin Active and Planet Fitness local club memberships.
9. During the campaign, qualifying Discovery employees who activate the Gym benefit will pay **ZERO** activation fee when joining either Virgin Active or Planet Fitness.
10. You will be required to pay the club access device (access card) fee to join Virgin Active or Planet Fitness.
11. Discovery Vitality members get up to 75% off your monthly local club membership fees. You must visit the gym at least 36 times in a rolling 12-month period and exercise for 30+ minutes per visit to get the maximum 75% discount on a single local club membership.

12. To qualify for this offer, you will need to sign:
 - 12.1. At least a 12-month gym contract (local club membership) with your preferred gym partner (Virgin Active or Planet Fitness).
 - 12.2. A debit order instruction (mandate) and provide your banking details for your monthly gym fees debit order.
13. For Vitality Active, this campaign applies to Virgin Active local club memberships only.
14. If you use the Vitality Virgin Active benefit, you cannot join Planet Fitness at the Vitality rates. If you use the Vitality Planet Fitness benefit, you cannot join Virgin Active at the Vitality rates.
15. If you want to cancel your gym membership at the end of the promotion period, the following will apply: You will need to request the cancellation of your contract with your selected gym directly.
16. The gym's standard cancellation rules will apply, meaning that if you are still within your initial 12-month contract period, you will have to pay a cancellation fee that's linked to the outstanding balance of the 12-month contract.
17. These details will be in the contract you sign at the selected gym.
18. Your Vitality gym benefit monthly fee discount will stop at the end of your notice period. You'll need to give your gym one month's notice before the cancellation takes effect.
19. During the notice period, you may not start another gym benefit through Discovery Bank or Discovery Vitality.

General conditions

20. Offer valid for new members only at Virgin Active and Planet Fitness Clubs in South Africa.
21. Membership must be active and authorised from 9 March 2026 until midnight 30 April 2026.
22. No multiple campaign benefits: you may not participate in more than one new-joiner campaign within your initial 12- or 24-month period.
23. You may not cancel within your cooling-off or initial commitment period to retain the discount.
24. Discounts apply only while your gym membership fees are up to date with Virgin Active / Planet Fitness.
25. Offers cannot be exchanged for cash, refunds, or rebates.
26. Club facilities and class offerings vary by location.
27. Your quoted 2026 rate remains applicable in 2026, no price increase is applied unless upgrading, downgrading or your club has a revamp during this time.
28. You need to get your own tax advice about any benefit you may get in terms of these rules. Discovery Vitality will not be responsible for any tax consequences.
29. Unless otherwise stated, this offer cannot be used in conjunction with any other promotion.
30. Any offers, discounts and rewards that apply are limited to the confines of this promotion and depend on your acceptance and compliance with these terms and conditions.

Exclusions

31. This offer is not available to Discovery employees' families, spouses, children or friends.
32. This offer is not available to existing Virgin Active or Planet Fitness members or membership conversions of any kind.
33. This offer is not available to Virgin Active or Planet Fitness members with unsettled arrears or

disciplinary issues.

34. This offer is not available to Virgin Active or Planet Fitness members who are downgrading, upgrading or converting to any other membership type (including Corporate Conversions and Upgrades to Collection).
35. This offer is not available for nationwide gym memberships or Collection Club memberships.
36. This offer does not extend to the costs of access device fees.





Additional terms and conditions
