

The following terms and conditions apply to the Vitality Gym for Free for The Rest Of 2021 Promotion. This campaign will run from 1 October 2021 to 31 December 2021.

The promotion

1. The Promoters of the Discovery Vitality Gym for Free for The Rest Of 2021 promotion are Discovery Vitality (Pty) Limited ("Discovery Vitality"), Virgin Active South Africa (Pty) Limited ("Virgin Active") and Planet Fitness Holdings (Pty) Limited ("Planet Fitness").
2. This promotion is open to:
 - 2.1. Vitality Health, Vitality Purple, and Vitality Active members over the age of 18 years old ("Vitality members") who have not activated the Vitality Gym benefit with Planet Fitness or Virgin Active.
3. The promotion will start on 1 October 2021 and end on 31 December 2021 ("Campaign Period").

4. The promotion is as follows:

- 4.1. For the duration of the Campaign Period, Vitality members who activate the Vitality Gym benefit will not pay an activation fee when joining Virgin Active or Planet Fitness.
- 4.2. Vitality members that activate the Vitality Gym benefit at Virgin Active or Planet fitness during the Campaign Period will not have to pay their applicable gym monthly fees for the months up to and including 31 December 2021.
- 4.3. To qualify for this offer, Vitality members will need to sign a 12-month gym contract with Virgin Active or Planet Fitness health clubs.
- 4.4. To find out the retail rates, contact your nearest Virgin Active or Planet Fitness health club.
- 4.5. Where applicable, pay the club access device or tag fee for each member activating the Vitality gym benefit.
- 4.6. Sign a debit order instruction (mandate) and provide your banking details for your monthly gym fees debit order. The monthly gym fees will be applicable after the expiry of the Campaign Period – this means that your first debit order will be for January 2022.
- 4.7. For Vitality Active members, this promotion is applicable to Virgin Active Club, Planet Fitness Local gym memberships, Virgin Active RED clubs and Planet Fitness Just Gym clubs.
- 4.8. For Vitality Health members, this promotion is also applicable to Virgin Active Club, Premier and Collection gym memberships, and Planet Fitness Local and National gym memberships.



- 4.9. For Vitality Purple members, this promotion is also applicable to Virgin Active Club, Premier and Collection gym memberships, and Planet Fitness Local and National gym memberships.
- 4.10. If you use the Vitality Virgin Active benefit, you cannot join Planet Fitness at the Vitality rates and if you use the Vitality Planet Fitness benefit, you cannot join Virgin Active at the Vitality rates.
- 4.11. This promotion extends to access device fees for Virgin Active gym memberships only **but does not** extend to tag fees for Planet Fitness gym memberships. Vitality members are still liable to pay for their tag fees at Planet Fitness.
- 4.12. Should you want to cancel your Virgin Active or Planet Fitness gym membership at the end of the Campaign Period:
 - 4.12.1. you need to request the cancellation of your contract with your health club directly.
 - 4.12.2. The health clubs standard cancellation rules will apply, meaning that if you are still within your initial 12-month contract period, there is a cancellation fee linked to the outstanding balance of the 12-month contract.
 - 4.12.3. These details will be in the contract you sign at the health club.
 - 4.12.4. Your Vitality gym benefit monthly fee discount will stop at the end of your notice period. You'll need to give your health club one months' notice prior to cancellation.
 - 4.12.5. During the notice period, you may not start another health club benefit through Vitality.







General

5. The Promoters reserve the right to alter or terminate the promotion at their discretion. In the event of such alteration or termination, all participants shall waive any rights which they may have against the Promoters, their affiliates or associated companies and acknowledge that they will have no recourse or claim of any nature against the Promoters. Prior notice will be given to the participants in the event of such alteration or termination.
