



Vitality Active rewards Campaign – Terms and conditions

For a limited time period, Discovery Vitality is offering members an extra incentive to stay fit. From 3 April 2021 until 3 July 2021, you can access a R250 Netflix reward at D150 (usually D2500) when you meet your exercise goal, subject to the following terms and conditions.

1. The promoter of this offering is Discovery Vitality (Pty) Ltd ('Discovery Vitality')
2. Any offers and discounts applicable to a Netflix subscription are limited to the confines of this campaign and are subject to participant's compliance with these terms and conditions
3. The offer enables members to receive a R250 Netflix reward at D150 (usually D2500) when you meet your exercise goal for the week,
4. The offering is limited to members aged 18 and older who have activated Vitality Active Rewards
5. No additional discount is applied to the special Netflix campaign reward.
6. The first reward cycle will commence on 3 April 2021 and the last reward cycle will end on 3 July 2021.
7. Late events will not be considered for this benefit over the campaign period.
8. The discounted reward is limited to two rewards over the campaign period only and subject to only one reward selection in the qualifying month rewards cycle.
 - a. For the avoidance of doubt, participants will be allowed a maximum of 2 rewards during the campaign period at a limit of one reward per qualifying month reward cycle

9. Only exercise goals achieved within the campaign period will be eligible for the discounted reward, provided that the member has not selected the reward twice during the three month period.
10. Upon achieving their exercise goal, members have until the end of the current month to select their discounted Netflix reward, if the reward is earned within the current months reward cycle

Example 1:

If a member achieves their first exercise goal for the month on 29 May 2021, they can select the discounted Netflix reward from 1 June 2021 until 30 June 2021. This is because the reward cycle runs from 29 May until 4 June 2021, therefore the goal is allocated in June 2021.

Example 2:

If a member achieves their first exercise goal for the month 29 April 2021, they can select the discounted Netflix reward from 29 April to 30 April 2021. This is because the reward cycle runs from 24 to 30 April 2021, therefore the goal is allocated in April 2021.

11. Where the reward cycle end date occurs in the next month, members will be able to select their reward from the beginning of the next month until the end of the next month. Except in July when the campaigns ends and members will need to have selected their reward before 3 July 2021.
12. Qualifying criteria:
 - a) Member achieves one exercise goal in the campaign period
 - b) Member has not exceeded the limit of two rewards per the the campaign period
 - c) Member has activated Vitality Active Rewards
13. This campaign will not be available on other Vitality programmes, including VAR for SAB, VAR for Doctors, KeyFit, Vitality Health Tracker and Remedi Healthy Food.
14. This offer is only valid in South Africa.
15. This offer cannot be used in conjunction with any other offer.
16. Vouchers cannot be exchanged for cash or transferred.
17. The reward is valid only towards the Netflix service via Netflix account (18+ or age of majority to become a member), in South Africa.
18. This reward is valued at R250 and will be viewable on the Discovery app for 3 months from date of selection
