

## Terms and Conditions for the Vitality Active Rewards for Kids x Sony PlayStation competition


1. The promoters of the competition are Discovery Vitality (Pty) Ltd ("Vitality") and Sony Interactive Entertainment Europe Limited, trading as Sony PlayStation.
2. The competition will run from 09 December 2020 to 14 February 2021. The closing date of the competition is midnight 14 February 2021.
3. Entrants into the competition are required to reside in South Africa.
  - 3.1 The competition is open to Vitality members who have activated Vitality Active Rewards and have child dependants between the ages of 2 to 14. The main member will be entering the competition on behalf of the child dependant.
