

#### Who this investment may be suitable for

This fund is suitable for investors looking to access a diversified mix of asset classes to achieve moderate returns with reduced levels of volatility.

#### Fund investment policy

The objective of the fund is to provide steady income and capital growth from an actively managed portfolio, diversified by major asset classes, at a lower level of volatility than the typical equity or balanced fund. The manager aims to do this by investing in a balanced manner, with equity exposure moderated in order to reduce the risk of capital loss during unfavourable market conditions. The portfolio would thus expect to have a low to moderate risk profile, with notably higher equity exposure than the Discovery Cautious Balanced Fund, but notably lower equity exposure than the Discovery Balanced Fund. The fund's maximum equity limit is 60%.

To achieve its objective, the manager will invest in JSE listed companies, listed gilts and interest bearing securities, money market instruments, listed property securities, listed derivatives, unlisted derivatives, participatory interests in collective investment schemes and foreign investments and unlisted securities as permitted from time to time by the Act. The allocation of investments to be included in the fund will be appropriate for retirement funds.



#### Glossary

*Sharpe Ratio* - this is a measure of the excess return an investor receives for the additional volatility that they endure for holding a riskier asset. This compares the return on an investment with its risk.

*Information Ratio* - this is a measure of the risk-adjusted return of a portfolio relative to a certain benchmark.

#### Important information

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. The ability of the portfolio to repurchase, is dependent upon the liquidity of the securities and cash of the portfolio. A manager may suspend repurchases for a period, subject to regulatory approval, to await liquidity, and the manager must keep the investors informed about these circumstances.

Lump-sum performance returns are being quoted. Income distributions, prior to deduction of applicable taxes, are included in the performance calculations. The rate of return is calculated on a total return basis, and the following elements may involve a reduction of the investor's capital: interest rates, economic outlook, inflation, deflation, economic and political shocks or changes in economic policy. Annualised returns are period returns re-scaled to a period of one year. This allows investors to compare returns of different assets that they have owned for different lengths of time. All period returns greater than one year have been annualised. Returns for periods less than one year have not been annualised. #### What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the investment of the portfolio. It is the sum of the TER and TC.
