

Who this investment may be suitable for

This fund is suitable for investors looking for capital growth and a regular income and who are using this fund as part of a diversified investment portfolio.

Fund investment policy

The objective of the portfolio is to provide capital growth and an income yield to investors that intend to invest for the long term, predominantly through exposure to listed property securities, whilst at the same time maintaining a medium risk profile.

In order to achieve its objective, the manager will invest principally in a mixture of property securities listed on the JSE, specifically listed participatory interests in collective investment schemes in property and listed property loan stock as well as offshore investments as permitted by legislation. The fund will also invest in listed gilts and interest bearing securities, unlisted derivative instruments, money market instruments, unlisted securities and listed derivative instruments.

The portfolio may also include participatory interests or any other form of participation in portfolios of collective investment schemes or other similar schemes, as permitted by legislation.



Glossary

Sharpe Ratio - this is a measure of the excess return an investor receives for the additional volatility that they endure for holding a riskier asset. This compares the return on an investment with its risk.

Information Ratio - this is a measure of the risk-adjusted return of a portfolio relative to a certain benchmark.

Important information

The collective investment scheme may borrow up to 10% of the market value of the portfolio to bridge insufficient liquidity. The ability of the portfolio to repurchase, is dependent upon the liquidity of the securities and cash of the portfolio. A manager may suspend repurchases for a period, subject to regulatory approval, to await liquidity, and the manager must keep the investors informed about these circumstances.

Lump-sum performance returns are being quoted. Income distributions, prior to deduction of applicable taxes, are included in the performance calculations. NAV to NAV figures have been used for the performance calculations, as calculated by the manager at the valuation point defined in the deed, over all reporting periods. Investment performance calculations are available for verification upon request by any person. Reinvestment of income is calculated on the actual amount distributed per participatory interest, using the ex-dividend date NAV price of the applicable class of the portfolio, irrespective of the actual reinvestment date. The performance is calculated for the fee class. The individual investor performance may differ, as a result of initial fees, the actual investment date, the date of reinvestment and dividend withholding tax. The rate of return is calculated on a total return basis, and the following elements may involve a reduction of the investor's capital: interest rates, economic outlook, inflation, deflation, economic and political shocks or changes in economic policy. Annualised returns are period returns re-scaled to a period of one year. This allows investors to compare returns of different assets that they have owned for different lengths of time. All period returns greater than one year have been annualised. Returns for periods less than one year have not been annualised. A cumulative return is the aggregate amount an investment has gained or lost over time, independent of the period of time involved. Actual annual figures are available to the investor on request. What is the total investment charge (TIC)

Total expense ratio (TER) is the percentage of the value of the portfolio that was incurred as expenses relating to the administration (charges, levies and fees) of the portfolio. TER is calculated over rolling 3 years (or since inception, where applicable), and is annualised, to the most recent calendar quarter-end. A higher TER does not necessarily imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction costs (TC) is the percentage of the value of the portfolio that was incurred as costs relating to the buying and selling of the assets underlying the portfolio. Transaction Costs are a necessary cost in administering the portfolio and impacts portfolio returns. It should not be considered in isolation, as returns may be impacted by many other factors over time, including market returns, the type of financial product, the investment decisions of the investment manager, and the TER. Calculations are based on actual data, where possible, and best estimates, where actual data is not available. Total investment charges (TIC) is the percentage of the value of the portfolio that was incurred as costs relating to the investment of the portfolio. It is the sum of the TER and TC.
