### Funds Overview

The Cogence Discovery Dynamic Asset Optimiser Fund of Funds (Life) aim to achieve results that outperform their benchmark over the medium to long term.

The funds use a diversified portfolio of Discovery and Cogence Funds and a sophisticated asset allocation model, developed by BlackRock, to optimise return at the relevant risk level on an ongoing basis. The model is designed to monitor and regularly rebalance the various asset class exposures according to the relevant risk profile to maximise returns. The asset mix in each fund complies to the limits imposed by Regulation 28 of the Pension Funds Act.

### Funds Objectives

**Balanced DAO Fund of Funds (Life)** invests within an aggressive risk profile, optimising investment returns and aiming to provide capital growth and income with moderate volatility.

**Moderate DAO Fund of Funds (Life)** invests within a moderate risk profile and aims to provide a balance of capital preservation and income.

**Cautious DAO Fund of Funds (Life)** invests within a conservative risk profile and aims to provide capital protection.


