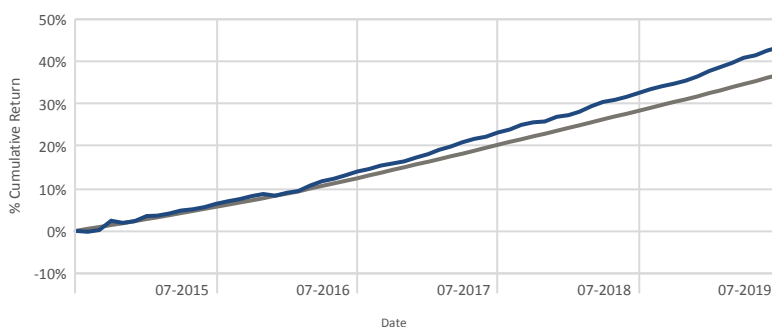
INVESTMENT OBJECTIVE

The Select Manager BCI Income Fund of Funds is an income generating fund of funds. The investment objective of the portfolio is to provide regular, stable and above-average income returns, while protecting the value of capital invested.

INVESTMENT UNIVERSE

Investments to be included in the portfolio will, apart from assets in liquid form, consist solely of participatory interests and other forms of participation of local and global collective investment schemes. The underlying portfolios may invest in, equity securities, property securities, non-equity securities, money market instruments, preference shares, listed and unlisted financial instruments, bonds and other interest-bearing instruments and securities. The portfolio's equity exposure may be as high as 10% of the portfolio's net asset value.

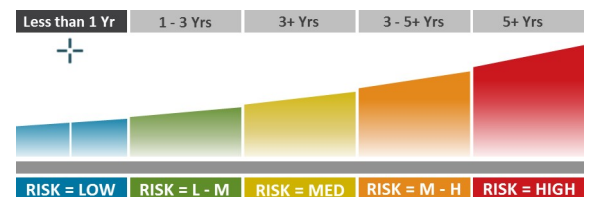
