






**Join Team Vitality Cycling Club by 23 October and send in your motivation to stand a chance to win a trip to Swellendam to participate in the Double Century Cycle event as part of the Team Vitality Team, captained by Nic White.**

3. Any activities/entries made before or after these dates will not be considered.

  - b. Sign the debit order mandate which will enable their current Team Vitality Cycling or Combo Club membership to be auto renewed for 2021.
  - c. Participants then need to send an email motivation to [RSVP@teamvitality.co.za](mailto:RSVP@teamvitality.co.za) with a motivation on why they should win the trip to Swellendam to cycle the Double Century Cycling as part of the Team Vitality cycling team
5. Based on the following criteria, team captain, Nic White will make the team selection:
  - a. Entrants longest distance ridden in 2019 and 2020
  - b. Participation in one or more long distance (more than 90 km) cycle races in 2019 and 2020
  - c. Review of participants last 3 months of training
  - d. Ability to commit to Nic White training schedule to prepare for the event which includes a minimum of 3 x 90 minute weekday rides and 1 x 5 hour ride, for a minimum of 3 weeks leading up to the event.
6. Participants may only enter once.
7. There will be 8 prize winners selected to join the Team Vitality cycling team entering the Double Century cycling event and the trip to Swellendam, Cape Town.
8. The prize consists of:
  - A ticket entry to the Double Century cycling event,
  - Flights to the Western Cape if the winner selected does not reside in the Western Cape.
  - Accommodation in Swellendam from 20 November to 22 November, breakfast included.
  - Bike transportation to the event and back from the event
  - Transportation includes:
    - Transport to Swellendam accommodation

- Transport from Swellendam accommodation to the event
  - From the event back to the Swellendam accommodation
  - Transportation from accommodation to the airport
