

## Vitality Active Rewards Summer Shake-Up Campaign – Terms and conditions

## Terms & Conditions:

For a limited time period, Discovery Vitality is offering members an extra incentive to stay fit. From 1 November 2021 until 31 December 2021 (Campaign Period), you can redeem a selected reward at a reduced Discovery Miles rate. From 1 November 2021, eligible Vitality Active Rewards members can get a R250 Sportsmans Warehouse or Totalsports reward per goal cycle within the Campaign Period at the same Discovery Miles rate of a coffee, at 150 Discovery Miles (usually 2500 Discovery Miles) when you meet your exercise goal, subject to the following terms and conditions.

- The promoter of this offering is Discovery Vitality (Pty) Ltd ('Discovery Vitality'), Totalsports and Sportsmans Warehouse.
- 2. Any offers and discounts applicable to Sportsmans Warehouse or Totalsports are limited to the offer enables qualifying Vitality Active Rewards participants to redeem a reward of either a R250 Sportsmans Warehouse or Totalsports reward at 150 Discovery Miles (usually 2500 Discovery Miles) when you meet your exercise goal for the week between 1 November to 31 December 2021.

- 6. Late events will be considered for this benefit over the campaign period if they fall within 30 October 26 November for the November reward and 27 November 31 December for the December reward.
  - 6.1 Late event must fall within a valid campaign period (e.g. before 27 November for the November reward, and before 31 December 2021 for the December reward).
  - 6.2 Late event must be received within the valid month to receive the reward (e.g. Late event for a November fitness goal must be received in November in order for the member to get their November reward)
- 7. Only exercise goals achieved and received by Vitality within the Campaign Period will be eligible for the discounted reward.
- 8. Upon achieving their exercise goal, members have until the end of the current month to select their discounted to Sportsmans Warehouse or Totalsports Reward, if the reward is earned within the current months reward cycle

## Example 1:

If a member achieves their first exercise goal for the month on 30 October 2021, they can select the discounted Sportsmans Warehouse or Totalsports reward from 1 November until 30 November 2021. This is because the reward cycle runs from 30 October - 26 November 2021, therefore the goal is allocated in November 2021

9. Where the reward cycle end date occurs in the next month, members will be able to select their reward from the beginning of the next month until the end of that month. Because the campaign ends In December, members will need to have selected their reward before 31 December 2021. Example 2:

If a member achieves their exercise goal for the month on 27 November 2021, they can select the discounted Sportsmans Warehouse or Totalsports reward from 1 December until 31 December 2021. This is because the reward cycle runs from 27 November - 31 December 2021, therefore the goal is allocated in December 2021

- 10. Qualifying criteria:
- 11. Member has activated Vitality Active Rewards
- 12. Member achieves one exercise goal in the campaign period
- 13. Member has not exceeded the limit of 1 reward per month
- 14. This campaign will not be available on other Vitality programmes, including VAR for SAB, VAR for Doctors, KeyFit, Vitality Health Tracker, Balance, VAR for HealthyCompany and Remedi Healthy Food.
- 15. This reward is only available to members 18 years or older regardless of their qualifying Vitality policy role.
