

## Team Vitality renewal campaign terms and conditions - 2022/2023

  - Select Join or Renew Team Vitality
  - Then tap on change reward detail or debit order account
  - Update your debit order banking details
- 6. If you choose to **not follow** the automatic renewal process, you can manually renew your membership from 15 November 2022 by visiting the Discovery website and selecting Team Vitality.
- 7. Any sign ups or renewals before or after this campaign period will not be considered.
