VARD Boosted Rewards Campaign Terms and Conditions

Vitality Active Rewards for Doctors- Boosted rewards for being a Doctor on VARD.

- 4. Boosted Quarterly rewards for Vitality Active Rewards for Doctors

In addition to the weekly rewards doctors compete on the VARD leaderboard and stand a chance to be one of 18 doctors who will each receive **50 000 Discovery Miles**.

- 4.1 These are quarterly rewards awarded to 18 Doctors consisting of:
 - 4 (four) Top achieving GPs nationally for the quarter
 - 2 (two) Top achieving Specialists nationally for the quarter
 - 8 (eight) Most improved GPs nationally for the quarter
 - 4 (four) Most improved Specialists nationally for the quarter
- 4.2 We assess the doctors' performance over a period of 3 (three) months for each quarter by monitoring their exercise goals achieved, points and number of active days through the Vitality Active Rewards programme. This data is then used to measure the top achievers and most improved GPs as reflected in clause 4.1.
- 4.2.1 The 18 (eighteen) top achieving and most improved doctors for the quarter will each receive **50 000 Discovery Miles**.
- 4.2.2 No part of the reward value can be redeemed as cash, converted to a credit, or exchanged for a voucher.
- 4.2.3 The reward redeemed before the expiry date. Discovery Miles expire after 5 years.
- 4.2.4 The reward may not be used in conjunction with any other promotion.
- 4.2.5 These Top performers will be notified via an email that will sent to the entire Vitality Active Rewards for Doctors Database. Only the names of doctors who have given us consent will be published. When a doctor has not given consent, only his/her specialty will be published on the email.

- 4.2.6 An SMS will be sent to confirm the Discovery Miles allocation.

- 4.2.8 The measurement is reset at the beginning of each new quarter and we assess the doctors' performance over the period of three months to get to the Top performers.
- 5. Wellness Commitment Awards: "We reward wellness campaign"- doctors achieving 50 (fifty) or more consecutive Vitality Active Rewards exercise goals.
- 5.1 These are bi-annual rewards are awarded in the form of Discovery Miles, and are awarded to doctors who achieve 50 (fifty) or more consecutive Vitality Active Rewards exercise goals from the inception of the Vitality Active Rewards for Doctors programme. The doctors are rewarded according to the following categories.
 - 50 to 99 consecutive VAR exercise goals- 5000 Discovery Miles.
 - 100 to 149 consecutive VAR exercise goals- 7500 Discovery Miles.

- 5.2.1 The Discovery Miles can only be used for purchases on the Vitality Mall if the doctor does not have a Discovery Bank account.
