



## Vitality HealthyDining Uber Eats Competition – Terms and conditions

- 2. The competition is limited to Vitality members over the age of 18 with HealthyDining activated and will run from 22 September 2021, 00:01 until 26 September 2021, 23:59. The closing date of the competition is 26 September 2021, 23:59.

  - a. <u>Activate Vitality HealthyDining</u> in the latest version of the Discovery app, select Vitality and then HealthyDining to activate the benefit. Remember to also link your Uber Eats account to your Vitality profile.
  - b. Order a HealthyDining meal on the Uber Eats app, from Col'Cacchio, Doppio Zero, Nando's or Mugg n Bean between 22 September and 26 September 2021. Each order will amount to one entry and multiple entries are permitted.
  - c. You'll go into a draw for a chance to win a promo code to the value of R1000 on Uber Eats to use on any of the HealthyDining partners you ordered from via Uber Eats during the campaign period.

- 6. The Uber Eats promo code will give the member R200 off their next 5 orders when they spend R200 or more. Only one R200 will be applied on a single order. The promo code may only be applied to orders made from select, participating restaurants. Participants are encouraged to consider the Uber Eats app for additional terms and conditions, which may apply.
- 7. The draw will take place during the week of 27 September to 1 October 2021. We will contact the winner by 11 October, with the Uber Eats promo code.
