

# **CONSTITUTION OF BOARD AND BOARD COMMITTEES**

Discovery Health Medical Scheme, registration number 1125, is regulated by the Council for Medical Schemes and administered by Discovery Health (Pty) Ltd, registration number 1997/013480/07, an authorised financial services provider.



# 1. Board Composition

Discovery Health Medical Scheme's ("DHMS"/"the Scheme") Board of Trustees ("Board") comprises a maximum of eight members, consisting of a majority of Trustees. Rule 17.1 provides that the affairs of the Scheme must be managed according to these Rules by a Board of fit and proper persons (i.e. persons with the requisite character, integrity, skill, competence, financial soundness and ability to exercise a fiduciary duty) of at least five and a maximum of eight persons.

# 2. Committee Composition

### 2.1. Audit Committee

The Audit Committee ("the Committee") is a statutory sub-committee of the Board established in terms of Section 36(10) to (13) of the Medical Schemes Act 131 of 1998 ("Act"). The terms of reference state that the Committee shall have at least five members of which at least two shall be members of the Board. The majority of the members, including the Chairperson, shall be independent members and not be members of the Board.

### 2.2. Clinical Governance Committee

The Clinical Governance Committee ("the Committee") is established in terms of Rule 19.3 of the Scheme Rules. The purpose of the Committee is to assist the Board in the general oversight of funding policies and practices, clinical governance and providing access to evidence based, clinically appropriate, cost-effective, affordable, quality healthcare in a consistent and equitable manner. The Committee shall be constituted of at least three members with the required expertise, at least one of whom shall be a Trustee of the Board, and the Chief Medical Officer of DHMS.

## 2.3. Disputes Committee

The Committee consists of practicing medical professionals and attorneys who are independent from Discovery Health Medical Scheme and Discovery Health. Each Disputes Panel is drawn from the Committee to hear and adjudicate over individual disputes lodged by members, and consists of three members drawn from the greater Disputes Committee. Each Panel presiding over any dispute hearing requires at least one legal expert and at least one medical expert and the Chairperson is always a practicing attorney. Due to the independent nature of the relationship and the variation of panelists, membership is not detailed here.

## 2.4. Investment Committee

The Investment Committee ("the Committee") is established for the purpose of recommending and overseeing the implementation and maintenance of investment policies. The terms of reference state that the Committee shall be constituted of at least four members, with a maximum of seven, the majority of which shall be members of the Board.

# 2.7. Remuneration Committee

The purpose of the Remuneration Committee ("the Committee") is to ensure remuneration policies that are fair and responsible for all staff levels in the Scheme, including the remuneration of senior executives of the Scheme, the Principal Officer, Trustees and Board Committee members. The Committee shall be constituted of at least three members, one of whom shall be an independent member. The Chairman of the Board shall be a member of the Committee and the Principal Officer shall be an invitee to the Committee.

#### 2.8. Risk Committee

The Independent members shall be in the minority, relative to the Trustees, Principal Officer and responsible Scheme Executive. The Chairperson of the Audit Committee shall serve as member of the Risk Committee.

# 2.9. Stakeholder Relations and Ethics Committee

The Committee must have a minimum of three members, of which at least two must be Trustees and one of whom must be a member of the medical profession. The Principal Officer is also a member. The Committee may appoint one independent member, according to requirements for skills and/or succession planning as may arise from time to time.
