Overview

The Specialised Medicine and Technology Benefit gives members on the Executive and Classic Comprehensive Plan access to specific high-cost medicines and new technologies. This benefit is not available on the Classic Smart Comprehensive Plan. This document explains how the benefit works, how we pay for treatment from the Specialised Medicine and Technology Benefit and the process you need to follow to apply for the benefit.

About some of the terms we use in this document

There may be some terms we refer to in the document that you may not be familiar with. Here are the meanings of these terms.

TERMINOLOGY	DESCRIPTION
Above Threshold Benefit (ATB)	Available on the Executive, Comprehensive and Priority plans Once the day-to-day claims you have sent to us add up to the Annual Threshold, we pay the rest of your day-to-day claims from the Above Threshold Benefit (ATB), at the Discovery Health Rate (DHR) or a portion of it. The Executive Plan has an unlimited Above Threshold Benefit (ATB), and the Comprehensive and Priority plans have a limited ATB.
Discovery Health Rate (DHR)	This is a rate we pay for healthcare services from hospitals, pharmacies, healthcare professionals and other providers of relevant health services.
Medical Savings Account (MSA)	Available on the Executive, Comprehensive, Priority and Saver plans The Medical Savings Account (MSA) is an amount that gets allocated to you at the beginning of each year or when you join the Scheme. You pay this amount back in equal portions as part of your monthly contribution. We pay your day-to-day medical expenses such as GP and specialist consultations, acute medicine, radiology and pathology from the available funds allocated to your MSA. You can choose to have your claims paid from the MSA either at the Discovery Health Rate, or at cost. Any unused funds will carry over to the next year. Should you leave the Scheme or change your plan during the year and have used more of the funds than what you have contributed, you will need to pay the difference to us.
Reference Price	The reference price is the set amount we pay for medicine, relative to a similar medicine on the medicine list (formulary) or the preferentially priced equivalent.

The Specialised Medicine and Technology Benefit at a glance

The Specialised Medicine and Technology Benefit provides additional cover for a defined list of high-cost medicines, new technologies and procedures up to a limit of R200 000 for each person, each year, subject to specific rules. Cover is either at 80% or 100% of the Discovery Health Rate (DHR) or Reference Price, depending on the treatment, as outlined in the table below. Where the provider charges more than the Discovery Health Rate (DHR), you will have to pay the difference.

Cover from the Specialised Medicine and Technology Benefit is subject to entry criteria

To access this benefit, which covers certain treatments for specific indications, you must meet the benefit entry criteria which are developed using evidence-based medicine. These criteria are updated in accordance with local and international best practice as well as clinical protocols, where applicable.

If you do not meet the criteria for funding from the Specialised Medicine and Technology Benefit, you can access funding through the available funds allocated to your Medical Savings Account (MSA) and Above Threshold Benefit (ATB), subject to the prescribed medicine limit, where applicable.

You must apply for cover

You need to complete a Chronic Illness Benefit application form for cover from the Specialised Medicine and Technology Benefit. Up to date forms are always available on <u>www.discovery.co.za</u> under Medical Aid > Manage your health plan > Find important documents and certificates.


