Who qualifies for Junior Team Vitality?

If your child is between the ages of 16 to 18 years with an active Vitality membership, they can register with Junior Team Vitality and join at any time during the year. The Junior Team Vitality membership is valid for one calendar year and will end automatically on 31 December each year.

The Junior Team Vitality membership is not automatically renewed.

The annual membership fee is R235. Please note that Athletics South Africa (ASA) province licence fees will apply for 2025 licences.

If you require a junior running licence, you can only activate this benefit if you are in one of our licensed regions: Central Gauteng, Gauteng North, KwaZulu-Natal, Eastern Province and Western Cape.

Getting started

Complete the application form and pay the registration fee by EFT. After this, email your application form and proof of payment to us at Team_Vitality_Documents@discovery.co.za. Upon activation, we will send you a welcome email from Team Vitality which will give you access to the voucher codes to redeem your child's Junior Team Vitality kit.

Cancelling the Junior Team Vitality benefit

When you activate Junior Team Vitality and pay the membership fee, a no-cancellation policy applies. This means that we will not refund you (pay you back) once you pay the membership fee. If you choose to end your child's benefit or your Vitality policy, the ordinary rules for ending a benefit and Vitality membership will apply.

When your child turns 18, they can remain on the benefit for the remainder of the year, after that they will not qualify for the Junior Team Vitality benefit.

When membership ends

Your child will have access to this benefit until the end of the calendar year in which they joined. They will have to activate the benefit at the beginning of each calendar year if they want to remain part of the Junior Team Vitality movement. The benefit will end if your Discovery Vitality membership is no longer active or your child turns 18 years old.

Definitions

- **Discovery Limited** means Discovery Limited with registration number 1999/07789/06, a public company duly registered and incorporated in terms of the company laws of the Republic of South Africa and its subsidiaries.
- **Discovery Vitality** means Discovery Vitality (Pty) Limited bearing registration number 1999/007736/07, a company duly registered and incorporated in accordance with the company laws of the Republic of South Africa.
- **Team Vitality** means Discovery Athletic Club (NPO) registration number 092-844-NPO, operating as Team Vitality.
- **Personal information** means information relating to an identifiable, living, natural person, and where it is applicable, an identifiable, existing juristic person, including:
 - Information relating to the race, sex, pregnancy, marital status, national, ethnic or social origin, colour, sexual orientation, age, physical or mental health, wellbeing, disability, religion, conscience, belief, culture, language and birth of the person

- Information relating to the education or the medical, financial, criminal or employment history of the person
- Any identifying number, symbol, email address, physical address, telephone number, location information, online identifier or other assignment to the person
- The biometric information of the person
- The personal opinions, views or preferences of the person
- Correspondence sent by the person that is implicitly or explicitly of a private or confidential nature or further correspondence that would reveal the contents of the original correspondence
- The views or opinions of another individual about the person
- The name of the person if it appears with other personal information relating to the person or if the disclosure of the name itself would reveal information about the person.
- **Competent person** means any person who is legally competent to consent to any action or decision being taken in respect of any matter concerning a child.
- **Data subject** means the person to whom personal information relates.
- **Regulator** means the Information Regulator established in terms of section 39 of the Protection of Personal Information Act 4 of 2013.

Establishment of Information Regulator

The Information Regulator:

- Has jurisdiction throughout the Republic of South Africa
- Is independent and is subject only to the Constitution and to the law and must be impartial and perform its functions and exercise its powers without fear, favour or prejudice
- Must exercise its powers and perform its functions in accordance with the Protection of Personal Information Act, 2013 and the Promotion of Access to Information Act
- Is accountable to the National Assembly.
