

Emirates Holidays Promotion Terms & Conditions

The Promoters

1. The Emirates Holidays Promotion (“**Promotion**”) is jointly promoted by:

 - **Discovery Vitality (Proprietary) Limited**. (Registration No. 1999/007736/07).
 - **Emirates**, established by Dubai Ruler’s Decree No. 2 of 1985 (as amended).

(Collectively referred to as the “**Promoters**”).

Promotion Details

2. Members who use the dedicated promotional link will receive the following discounts on Emirates Holidays booking :
 - **20% Discount:** Applicable to bookings for the following destinations:
 - Australia
 - Japan
 - Malaysia
 - United States of America
 - Vietnam

10% Discount: Applicable to all other Emirates Holidays bookings, including Dubai.

Booking Requirements

3. The discounts only apply to Emirates Holidays bookings made via the designated [promotional-link](#) provided through the Vitality Travel platform, and paid exclusively using a Discovery Bank credit card will qualify for the Promotion.
4. Bookings made through any other channels – including but not limited to Vitality Travel, Emirates Holidays call centre and third-party travel agents do not qualify for the Promotion).

Promotion Period

5. Booking Period: The Promotion is valid for bookings made between **14 April 2025 – 14 July 2025** (both dates inclusive).
