

Discovery Vitality Give2Move School Sport Shoe Donation Terms and Conditions (2025)

Discovery Vitality is offering schools across South Africa the chance to win a share of a R100,000 cash prize by donating new or pre-loved running shoes and children's sports shoes as part of the Give2Move campaign, in collaboration with the Department of Sport, Arts & Culture.

1. **The competition will run from 08:00 on 1 June 2025 until 23:59 on 31 July 2025.**
2. Any donations made before or after these dates will not be considered for competition purposes.
3. **The last date by which schools may enter the competition is 15 July 2025.**
4. The competition is open to all schools across South Africa.
5. Qualifying entry criteria for schools to enter the competition:
 - a. Interested schools must complete an initial registration form and appoint a #VitalityGive2Move school champion who shall receive and respond to communication from Discovery Vitality.
 - b. **The school champion will receive a link to a tracking document which must be submitted at the end of the campaign (by 15 August 2025) as a final tally of shoes collected by the school (please refer to clause 12).**
 - c. Schools will receive a digital toolkit to use for marketing of the #VitalityGive2Move campaign which can be sent to parents, used in newsletters and/or on social media. The more shoes collected, the greater the chance of winning so students are encouraged to collect shoes from friends and family.
6. Shoes that are considered acceptable for donation include:
 - a. Running shoes (adults and children's shoes)
 - b. Sports shoes (including soccer boots, hockey boots, rugby boots, netball and tennis shoes etc)
 - c. Children's takkies
 - d. Shoes MUST be donated as a pair – single shoes will not be included in the school's total
 - e. Shoes must be cleaned as well as possible and the laces tied as a pair before donating them.
7. At the end of the collection period, shoes must please be placed in boxes or strong recycling bags and closed securely before they are dropped off at the designated Discovery drop-off points.
8. The bags / boxes of donated shoes can be delivered to the designated Discovery drop-off points that the school indicated in the initial MS registration form:
 - a. If less than 100 pairs – these can be delivered to Discovery Head Office (1 Discovery Place, Sandton, JHB) or at any Discovery Store across South Africa (find your nearest store [HERE](#))
Delivery times: Monday to Friday: 09:00 - 16:00 and Saturday: 09:00 - 13:00
 - b. If more than 100 pairs of shoes, please deliver to our regional warehouses in:
 - **Johannesburg:** Unit 10, Gallagher Place, Cnr. Suttie & Richards Drive, Midrand
 - **Durban:** 14 Edenberry Road, Avoca Hills, Durban
 - **Cape Town:** 1 Rusten Close, Marina da Gama, Cape Town
 - **Delivery times:** Monday to Thursday: 08:00 - 16:00 and Friday: 8:00 - 13:00
9. Participating schools will be categorised according to the number of students enrolled:
 - a. Schools with less than 1000 students
 - b. Schools with 1000 or more students

10. One school per category, that collects the most pairs of acceptable shoes, will each win R50,000.
11. In the event of a draw, the prize will be split equally between eligible schools.
12. Schools will have until **15 August 2025 (14 days from the competition closing date)** to complete the shoe donation tracking sheet and to deliver the shoes to the designated drop off points.
13. Shoes delivered will be counted and verified by representatives of Discovery Vitality. Falsification of numbers or non-compliance with any of the competition entry requirements will result in immediate disqualification of the school and ineligibility to win the prize.
14. The winning schools will be contacted on or before 15 September 2025 via email.
15. As the prize is a cash prize, it will be delivered via EFT upon receipt of a Bank verified proof of banking details from the winning schools.
16. The winners shall be selected in accordance with the applicable auditing processes.
17. Winning schools will need to get their own tax advice in respect of any prize and anything related thereto. The promoters are not responsible for any tax consequences.
18. Should the prize not be claimed within 30 calendar days the prize/s will be forfeited.
19. The Discovery Vitality retains full discretion to choose the winners. The decision is final and cannot be contested.
20. The winner acknowledges that the schools name as well as the principal and/or #VitalityGive2Move school champions names and photographs may be published within various media and could be asked to participate in media interviews relating to the Give2Move initiative subject to clause 22
21. With their written consent, the winning school and representatives may be asked to appear and be identified on Discovery Vitality and/or the Department of Sport, Art & Culture's official Facebook, Twitter and Instagram accounts. The prize winner may decline the option of appearing or being mentioned on these platforms and will not forfeit the prize should they elect to do so.
22. Any children or minors who are included in related photographs used by Discovery Vitality and/or the Department of Sport, Arts & Culture will require a formal consent form to be completed and returned by their parent/guardian. Furthermore, in the event that formal consents are required by law for any participation by children or minors related to this competition, such consents will need to be facilitated by the participating schools.
23. The prize is not transferable.
24. Any violation or attempt to violate any of the rules will result in immediate disqualification of the transgressor.
25. Discovery Vitality will not be held responsible for any misrepresentation caused due to an unintentional copy error, typing error or omission that may occur on any of our promotional material and communications.
26. Discovery Vitality reserves the right to revise, alter or terminate the competition at its discretion subject to notice. In the event of such alteration or termination, all participants shall waive any rights which they may have against the promoter/s, their affiliates or associated companies and acknowledge that they will have no recourse or claim of any nature against Discovery Vitality or any entity of the Discovery Group of Companies. Prior notice will be given to the participants in the event of such alteration or termination.
27. If required as a result of legislation or other legal reasons, Discovery Vitality reserve the right to terminate this competition immediately. In the event of such termination, all participants agree to waive any rights that they may have in terms of this offer and acknowledge that they will have no recourse against them.
